ORDINANCE NO. 2023-02 COMBINED ANNUAL BUDGET AND APPROPRIATION ORDINANCE OF THE NORTH SUBURBAN PUBLIC LIBRARY DISTRICT WINNEBAGO AND BOONE COUNTIES, ILLINOIS, FOR THE FISCAL YEAR BEGINNING JULY 1, 2023 AND ENDING JUNE 30, 2024

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE NORTH SUBURBAN PUBLIC LIBRARY DISTRICT OF WINNEBAGO AND BOONE COUNTIES, ILLINOIS, AS FOLLOWS:

SECTION 5: That a public hearing as to this Combined Annual Budget and appropriation Ordinance was held on August 17, 2023 at 5:00 p.m. at the Library, 6340 North Second Street, Loves Park, Illinois, which lies within the District.

SECTION 6: That the notice of the public hearing was given by publication in the *Rockford Register Star*, a newspaper published in the District at least 30 days prior to the time of the hearing, and that the Tentative Combined Annual Budget and Appropriation Ordinance has been made conveniently available to public inspection for at least 30 days prior to final action thereon.

SECTION 7: That the Secretary of the Board of Trustees of North Suburban Public Library District is hereby ordered and directed to cause publication of this Ordinance in the *Rockford Register Star* within 20 days hereafter, and to post a copy of this Ordinance in a public area of the District library building at 6340 North Second Street, Loves Park, Illinois within 3 days hereafter for a period of at least 14 days.

SECTION 8: That any unexpended balance in the General Operating Fund at the end of the Fiscal Year established herein shall be accumulated in the District's Special Reserve Fund.
